Trees, Parks & Ponds

Our common areas are one of the things that make Southern Village so special. The HOA spends most of its funds maintaining and improving these areas on behalf of the whole community. Here's an update on what we've done with your money recently.

This year's street tree maintenance program is almost complete. As part of that program we have pruned, fertilized and made larger mulch beds for 274 of our oldest and largest trees, in the Arlen Park area. We also replaced 29 struggling Linden trees on Highgrove with native Oaks more suited to our urban environment. Sadly, we also had to replace one tree on Parkside, destroyed by a vehicle, and another on Winston Ridge that was felled by a storm.

Admirers of the magnificent White Oak in Highgrove Park will be pleased to hear that we also completed a three-part treatment to suppress wood boring insects and canker disease in the trunk of this elderly tree.



This year, our main capital investment was new play sets in the Edgewater and Highgrove parks, and renovation of the equipment in Market park. All three of these projects were completed in June. Thanks to the many parent volunteers who assisted the HOA board by selecting the new playsets, negotiating discounts and assisting with project management. We hope your children or grandchildren are enjoying the new equipment too.

Next year, we hope to add a climbing frame for older children, to the Edgewater park. If you have any comments on this proposal, or other ideas for park improvements the board should consider for 2008, please email Jeremy Purbrick at jcp@nc.rr.com.

This year a new contractor took over the maintenance of our four ponds. Is it just me, or do the ponds really look better now: less trash and clearer water. The turtles aren't saying much, but I hear that the frogs agree.

Dick Lowe, 105 Nolen Lane, is a liasson member of SVHOA Board. SVTC meets about every two months or as needed to discuss and recommend action on all matters important to townhome owners.

We currently have members representing Highgrove Townhomes, Townhomes I, Townhomes II and Westend Townhomes. Soon, however, we will have vacancies on the committee and need one volunteer for Townhome I, two for Townhome II and two for Westend, a total of five good volunteers. Recently, we have been working to complete landscape enhancements for Highgrove, mulching projects for all townhomes, to clarify exterior maintenance responsibilities/procedures to be provided to all owners August 1, 2007, termite inspections, to interview/employ a new company, EcoScapes, for landscape maintenance (effective June 1, 2007) of all townhomes (you can expect improvement) and to gather competitive bids for scheduled paint/wood trim maintenance for 22 homes in Townhomes II.

SVTC does important work in representing owner interests and holding expenses down while preserving the increasing values of Southern Village Townhomes. If you have the interest and want to work with others to add value to your home and to have more enjoyment of your home, please volunteer.

SVHOA Treasurer Report

Dear Southern Village Neighbor,

Financially, 2007 will be another excellent year for the Southern Village Homeowners Association (SVHOA). As of May 31, I am pleased to report that SVHOA has \$113,000 in general reserves and \$30,000 in alleyway reserves.

Additionally, we continue to have the following controls over our finances:

- · On-line access to our accounts thus allowing the Treasurer to review real-time all our financial transactions
- · All expenditures over \$500 require the approval of both the Management Company and the appropriate Board member or committee chair
- · All checks over \$500 require the signature of both the Management Company and the Treasurer or President of the Board of Directors
- · Implementation of a fair but thorough collections policy for members who are late in paying dues
- · Monthly financial statements, which are prepared by the Management Company, are reviewed by the Treasurer prior to being issued
- Monthly financial statements and the 2007 annual budget are posted on the SVHOA web site, www.southernvillage.org.

Regarding next year's finances, the 2008 budget will be discussed this fall at the September and November Board of Directors meetings. Once it is approved it will be posted to the SVHOA website. Finally, it will be presented to the SVHOA membership at the February 2008 AGM.

If you live on an alley, you already know that Southern Village HOA is responsible for the upkeep of such. Because of this the SVHOA has been assessing an alleyway fee for two years now. Only those homes that live off an alley pay these additional fees. In 2006 the fee was \$32 per home per year. In 2007 the fee was increased to \$37. At present all monies are saved, meaning they are placed in reserves, for future alleyway expenditures. In fact, this summer, the SVHOA will be overseeing some minor repairs on existing alleyways.
